PETITION – SIDEWALK CONSTRUCTION REQUEST



TO: THE CITY OF MYRTLE BEACH, PUBIC WORKS DEPARTMENT:

We, the undersigned, being owners of record of property abutting

in Myrtle Beach, South Carolina, do hereby petition the City of Myrtle Beach to install sidewalk(s) within the right-of-way or right-of-way easements along the above-described street(s).

In so petitioning, we understand that we may be asked to dedicate permanent right-of-way easements and/or temporary construction easements to the City of Myrtle Beach for its use in constructing the project, that the project will not go forward unless and until all of such easements have been so dedicated, and it is our present intention to make such required dedications.

We further understand that the street must satisfy qualifying criteria to be eligible for new sidewalk construction.

We further understand that the location of the sidewalk will be determined by the City of Myrtle Beach depending upon established implementation guidance, continuity of sidewalks in the area, topography, stormwater conditions, presence of trees/shrubs and other utility conflicts or economic considerations.

We further understand that no portion of the cost of construction of the project shall be assessed against the abutting properties in connection with the project, and no exactions other than dedication of easements shall be required of the abutting property owners as a condition of proceeding with the project.

We further understand that seventy-five (75%) percent of the abutting property owners along both sides of the street indicates their desire for the construction of a new sidewalk.

It is further understood that only one property owner per property, including non-resident owners who are City of Myrtle Beach residents, must sign the petition and only one vote per property will be counted.

Where a Variance or Capital Improvement Installation Agreement exists requiring construction of infrastructure improvements by property owners, the City may require property owner installation of these improvements at the time of construction of the petitioned new sidewalk. We further understand that the same petition process for the installation of a sidewalk must be followed should there be a request to remove an existing sidewalk. It is further understood that if the construction of the sidewalk was initially led by a Sidewalk Construction Request petition, then the cost for removal is expected to be borne by property owners abutting the street.

Finally, we understand that the City reserves the right to proceed, or not to proceed, with the project, in its sole discretion. Shall this sidewalk construction request satisfy all qualifying criteria, both the Public Works Department and Bike & Pedestrian Committee have determined the best sidewalk solution after careful review of street conditions and safety considerations of the area, the Bike & Pedestrian Committee will submit the Annual Sidewalk Project Priority List to City Council for their consideration. Sidewalk installations may be approved by City Council motion and financially supported within the Capital Improvement Plan.
