- 1. Opioid Study Update Professor Robyn Causey.
  - Professor Causey spoke on results of phase 1 of study and that there are referrals being made for individuals to receive treatment, there are 17 documented regulated halfway houses in our area, there is no rep that is coordinating these services, several providers only accept cash payments, there are ongoing needs not being met in prevention, during intervention and recovery.
  - Representative Alan Clemmons working general assembly on both sides of legislative and funding sides in support of these efforts, eight bills have been signed by the Governor in the last week.
  - Representative Russell Fry spoke on testimony taken from law enforcement, families and teachers, medical professionals, to get a comprehensive view of how did this come to be, and what can the state do to address it? 15 pieces have been passed and signed by the Governor. There is a prescription drug monitoring program helps prevent "doctor shopping". When someone overdoses they want to receive treatment that day, but then they have to wait two weeks and that's a big problem, we are providing them with services straight into recovery so that they a chance to get clean. We're making huge strides.
  - Councilwoman Jeffcoat discussed that there was a meeting with hospital representatives and stated the need to make this a county wide initiative.
  - Councilman Render recalls of an informal breakfast in 2017, and that this has been an ongoing battle.
