<u>Applicant/Purpose</u>: Staff/ to rescind the moratorium on nightclubs, bars, and other drinking places in the area now known as the Arts and Innovation District.

Brief:

- In December, 2015 Council imposed a moratorium on new nightclubs, bars, and other drinking places following a number of criminal significant criminal activities in the area formerly known as the Superblock.
- This area is now the site of the Arts and Innovation District established through ordinance 2019-47 on September 24, 2019.
- The ART zoning designation sets forth the permitted uses in this area, so this moratorium is no longer relevant.
- No changes since 1st reading.

Issues:

• In December 2015, Council found that:

- The # of drinking establishments in this area had a negative impact on police services, & business diversity.
- o That the zoning allowances in place at that time were incompatible w/ the long range economic health & quality of police protection of this area as a family oriented destination.
- As a result of these issues Council asked Staff & Planning Commission to study this issue.
- During the pendency of that study ordinance 2015-77 prohibited the issuance of any new business licenses for such establishments in this area.
- Since that time, Council also adopted the Downtown Master Plan which identified this area as the Arts & Innovation District.
- Planning Commission studied & recommended uses for the proposed District, which were adopted by Council on September 24, 2019.
- The ART District allows bars, brew pubs, & taverns, but excludes nightclubs & sexually oriented businesses. All businesses in the new District must close by midnight.
- Adoption of the ART zoning classification makes the previous moratorium irrelevant.
