Go Fast Motorsports LLC currently owns a fleet of over 110 golf carts. These carts are owned outright with no loan or lease. Of the total carts many have been customized and improved. The total resale value of the carts is around \$450,000.

Go Fast Motorsports LLC currently owns a fleet of approximately 100 mopeds and trikes. These vehicles are also purchased up front, assembled and maintained. The total value is \$85,000.

In addition, we have amassed a large inventory of parts to be able to fix mopeds as needed with a value of over \$20,000

We have also purchased stickers, license plates, contracts, paperwork, helmets, locks and cables, parts, and tools to be prepared for this season. The yearly cost to print city required forms, buy plates, and tags cost over 5k yearly in addition to our normal operating expenses.

We currently have revamped our logos, printed employees shirts, and have a company vehicle and multiple trailers.

We also have maintained and serviced all the golf carts over the winter, installing wind shields and rear seats, checking motors and general maintenance, as well as lights, brakes, and tires.

Go Fast has a proven track record of paying all employees on time and without chargebacks, we pay all employees by check and on the record, never cash under the table as other companies do. All federal withholdings are done weekly to adhere to the new standards.

Go Fast pays its sales tax monthly via direct draft and has no debt or liens with the SCDOR or any other agency or entity.

Go Fast has the ability to borrow money as needed or self fund with over \$75,000 in reserves in bank accounts.

Go Fast Motorsports has been a popular tourist attraction since 2012, opening Sunshine Scooters in 2014 and reopening Savemart Scooters in 2019. Our company has provided the cities millions of tourist a cost effective and fun way to enjoy the beach and explore the city. Moped and golf cart rental is convenient and a necessity to the city for many reasons. Rental vehicles per hour offer some of the most fun and least expensive attractions per hourly rate of any attractions in the city, especially compared to thrill rides such as zip lines, sky wheel, ropes courses, go carts, and many other. Moped and golf cart rental allows family to be together and relax as they cruise down Ocean Drive or a convenient way to get to the beach with the kids. The goal of the city council should be to bring tourists year after year, while increasing revenue. By granting our franchise we are able to offer tourists a fun and affordable experience, we are able to hire and maintain local year-round employees and increase the tax base for the city.

With the continued increase in construction of hotel rooms, high rise condos and time share, we should expect an increase in number of visiting tourists each year. These tourists will bring additional vehicles with them. The option of renting a golf cart allows tourists to leave the car parked, reducing traffic congestion on primary roads, and take the golf cart instead. Our rental vehicles still contribute to paid parking spaces so there is no revenue loss to the city. Also, the increase in expected tourists, more heads on beds should prompt for an increase in the number of golf cart and moped permits being issued yearly. The increase for companies that need it means they have reinvested profits, hired more employees, are increasing business license revenues and paying increasing taxes yearly, a win for the city and the businesses.

In 2017 at the meetings with Mr. Pedersen and officer Lark and discussions with the city, we were allotted 186 total permits as a safe and allowable number to be shared by our 2 locations. This number represented the highest number we were issued in previous years and according to the city, this was a manageable number. In 2018, the first year of City Franchising, we were granted 150 permits, a REDUCTION of 36 units. I would like to state that this number is a SIGNIFICANT reduction from the number that we have had in years past for Memorial Day weekend. In past years we have purchased up to an additional 100 mopeds just to handle the demand for spring break and Memorial Day weekend at every location. At this time when the entire process was new and no one really knew what to expect, the city gave out numbers just by what was asked for and not based on sales, location, or any other measurable factors. This uneven distribution left some companies such as mine with too few tags for golf carts. Also, as the years pass, the demand for mopeds has decreased while the demand for golf carts has increased. Due to this and also keeping in mind the numbers allotted to all the other companies in the city we would like to slightly adjust the number of permits we are asking for in 2020. We are asking at Go Fast for 84 mopeds and 50 golf carts, an increase of 19 golf carts, at Sunshine we are asking for 25 mopeds and 20 golf carts, an increase of 10 golf carts as 20 represents the minimum number granted at all other locations, and at Savemart we are asking the same as last year, 19 moped and 20 golf cart tags. This is a total increase of 29 golf cart tags, which is less than the 36 we gave up in 2018. We feel as this is a fair and justifiable number, as we have increased our annual revenue to the city in both license fees and sales taxes. Also, we are seeing the increase in demand by families for

larger golf carts and have made the investment in such carts which provides more of what the customer wants while also helping our companies success and increased revenue to the city.

Go Fast and its other locations will now have an off-site location to store unused carts on days all our service and parts will also be offsite, so we can focus on the rentals and great customer service. not as busy to decrease clutter and improve the outside appearance of our locations.
