
1 **R2019-45: TO AUTHORIZE AN APPLICATION TO THE SOUTH**
2 **CAROLINA RURAL INFRASTRUCTURE AUTHORITY (RIA) BASIC**
3 **INFRASTRUCTURE GRANT PROGRAM IN THE AMOUNT OF \$500,000**
4 **FOR THE 5TH AVE. S. FORCE MAIN PROJECT; AND OTHER MATTERS**
5 **RELATED THERETO.**

6 **Applicant/Purpose:** Staff / to provide a resolution indicating the City’s intention to
7 submit a grant for the RIA Basic Infrastructure grant program for the 5th Ave. S. force
8 main project.

9
10 **Brief:**

- 11 • The Public Works Department has determined that the 5th Ave. S. and Boundary
12 Street intersection force main is in need of replacement.
- 13 • The replacement will involve the removal of the existing ductile iron pipe with
14 540 LF of new PVC out of the total 9,925 LF needed for the force main.
- 15 • The \$500,000, with no match requirement, will be used for the construction
16 activity improving the infrastructure that has reached the end of its useful life
17 and is in severely deteriorating condition which is negatively impacting the
18 system.

19 **Issues:**

- 20 • In proposed resolution Council:
 - 21 ○ Attests to the need for the \$500,000 in grant funding to implement this
 - 22 section of the 5th Ave. S. force main replacement project.
 - 23 ○ Will grant permission to the City Manager to apply for the grant on behalf of
 - 24 the City of Myrtle Beach.

26 **Public Notification:** Normal meeting notification.

28 **Alternatives:**

- 29 • Do not pass resolution.
- 30 • Amend resolution.

32 **Financial Impact:**

- 33 • 540 LF of new PVC out of the 9,925 LF needed for the force main will be
34 accomplished with grant funding from the RIA Basic Infrastructure grant
35 program.
- 36 • No match requirement.

18 NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Myrtle Beach, in meeting
19 duly assembled, that:

- 21 1. The City Manager and his designees are hereby authorized to submit application for a
22 Basic Infrastructure Grant from the South Carolina Rural Infrastructure Authority in the
23 proposed amount of \$500,000 for the purposes described in the above findings.
- 24 2. No local match is required or approved.
- 25 3. Upon approval of the subject grant, the acceptance, appropriation, and recording of
26 the grant funds in the amount of \$500,000 or other such approved amount is hereby
27 authorized.
- 28 4. The City Manager and his designees are hereby authorized to execute and deliver the
29 grant agreement and such related documents as may be required for this purpose.
