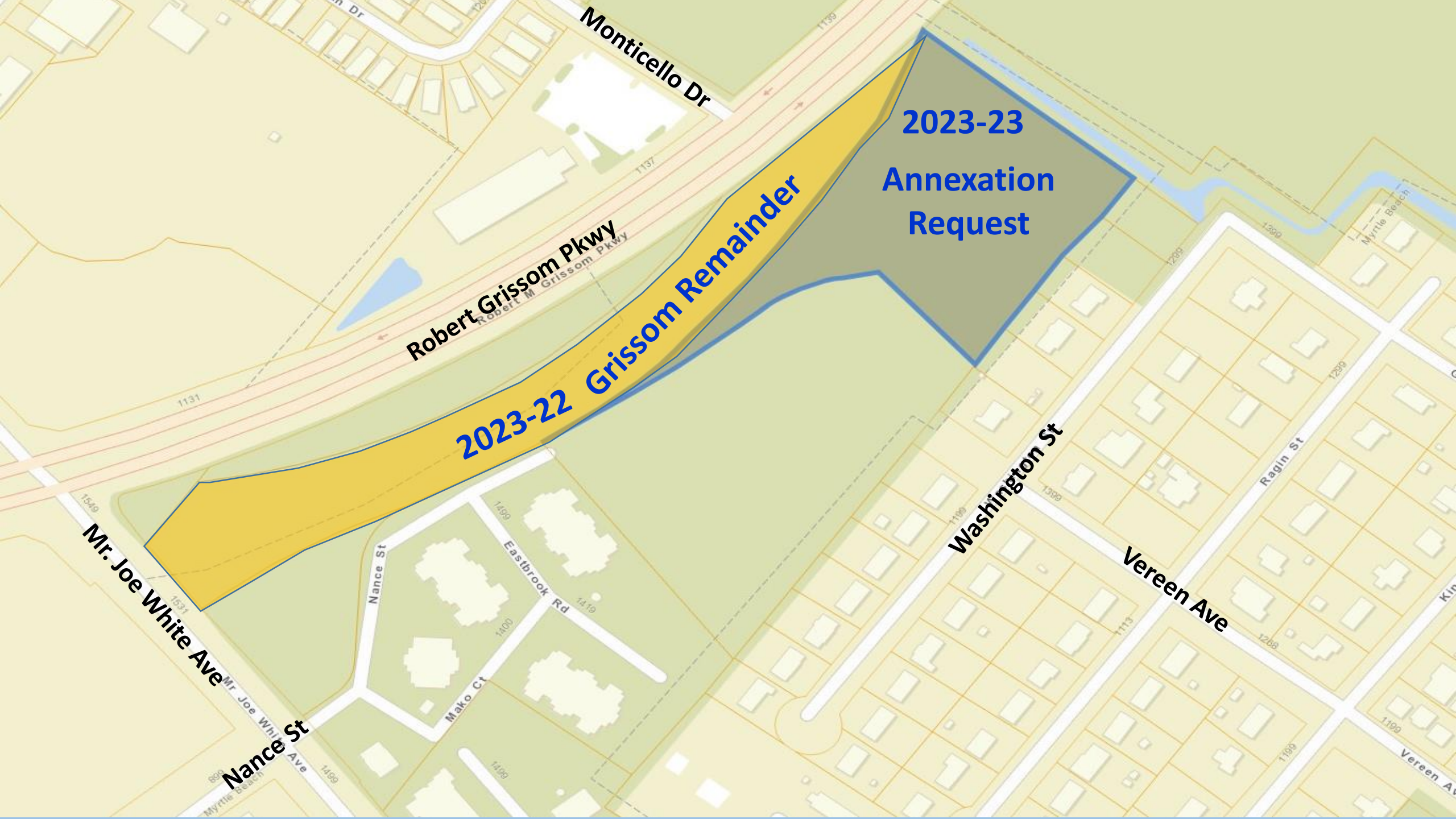


Ordinance 2023-22 to rezone ~0.59 acres on Grissom Pkwy (PIN 42512030009) from R10 (single family) to RMH – BTW (multifamily high density with the Booker T. Washington Overlay) and a small remainder portion from R10 (single family) to Mu-M (mixed use medium density) to allow for the continued development of Bay Pointe Apartments.

Ordinance 2023-23 to annex approximately ~3.23 acres at PIN 425-12-03-0058 and rezone from Horry County NC (Neighborhood Commercial) to City of Myrtle Beach RMH - BTW (Residential Multifamily High Density with the Booker T. Washington Overlay).

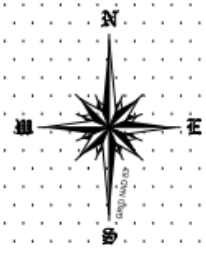

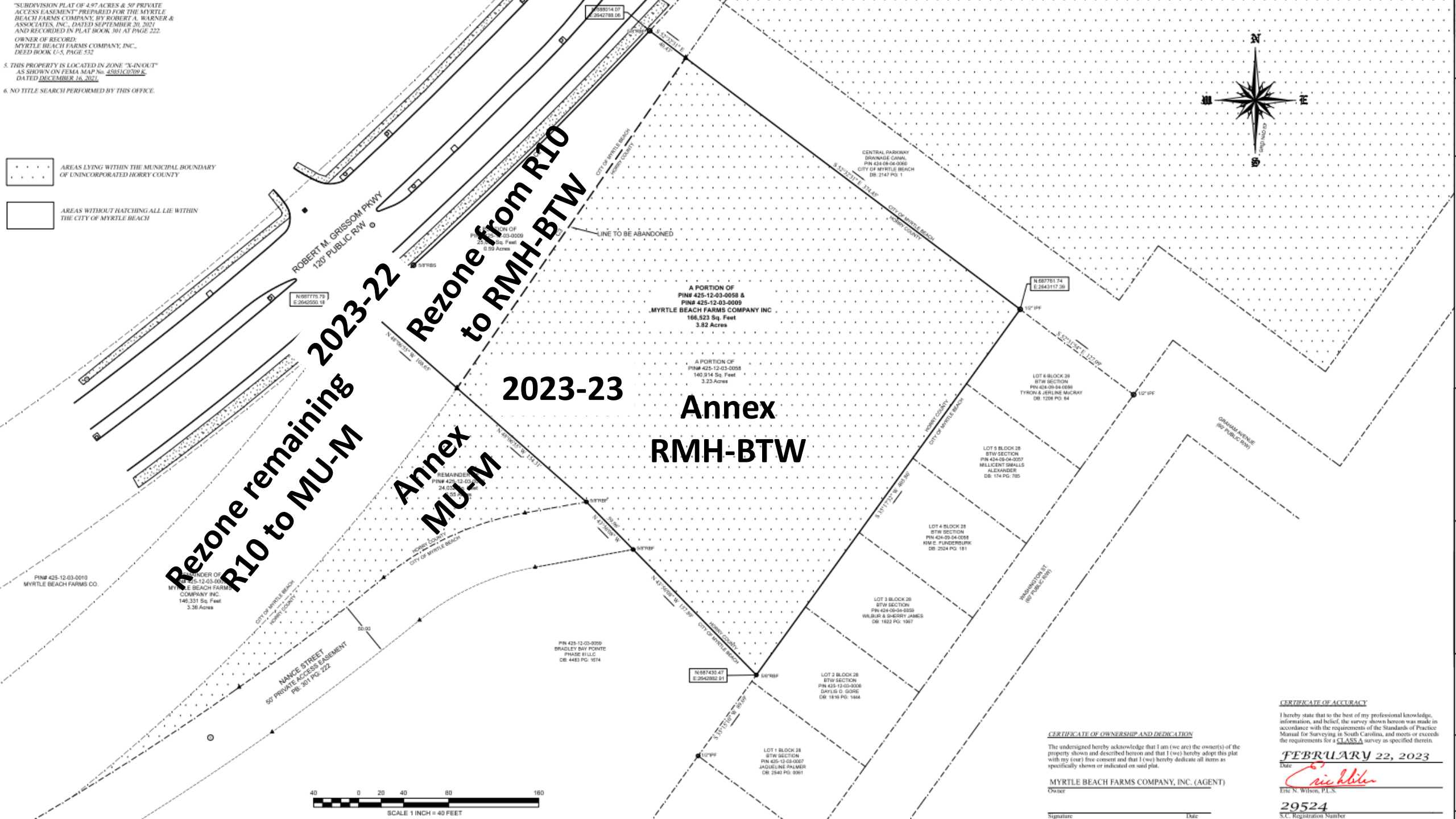
