Summer Festival at Grand Park

June 30th & July 1st

This event features live entertainment on a temporary stage, a kids' zone and vendors (arts & crafts, food, beer and wine). The operational hours for the festival will be from 11:00 am – 7:00pm on June 30th and 11:00pm-6:00pm on July 1st , 2018. The festival will be held at the Grand Park area of Market Commons, adjacent to Farrow Parkway. Traffic along Farrow Parkway will not be affected, except during the times when vendors will be permitted to load and unload their wares. At that time, the outer lane of travel in the easterly direction will be closed. Those times are as follows: between 6:00 pm and 8:00 pm on Friday, June 29th between 7:00am and 9:00am on Saturday, June 30th; and between 6:00pm and 7:00pm on Sunday, July 1st traffic travelling eastbound will not be affected in the inner lane. Barricades will be along the roadway to prevent the pedestrians from walking in the road and prevent motorist from driving up the curb along the curb for lane closure

The applicant will consult with Cultural and Leisure Services and the Myrtle Beach Police Department to provide appropriate road closure materials. The applicant will ensure all personal property, equipment and temporary structures are removed from the roadway no later than 7:00pm on Sunday, July 1st, 2018. Security during the operational hours of the event will be provided by police officers from the Myrtle Beach Police Department, the applicant's staff and volunteers. Police Officers will be responsible for crowd control, and normal patrol duties of the festival grounds. Police officers will be wearing appropriate uniform to readily identify them to members of the public. The applicant, at his discretion may hire private security for the protection of goods, merchandise or other private property stored on the festival grounds during operational and non-operational hours. The applicant's staff and volunteers will be responsible for enforcement of event policies, including alcohol and admission policies. EMS services will be provided by Myrtle Beach Fire Department including 2 EMTs and Utility Vehicle. Staff members from the Festa Italiana will make contact with

the EMTs to ensure that an agreed upon communication plan is established in the event an emergency arises. During the initial briefing the event staff will inform the EMTs of any prepositioned first aid station(s) if applicable.

The applicant will obtain the proper temporary beer/wine permits from SCDOR. The applicant will provide a list of names of all staff and volunteers, and will provide documentation of training for all staff and volunteers who will be involved in the service of alcoholic beverages. The training certifications must have been completed in the State of South Carolina by a company approved by the SCDOR. The list of names, training certificates and alcohol permits must be on file with the MBPD Special Events Coordinator by 5:00 pm on Monday, June 25th 2018.

No outside alcoholic beverages will be permitted inside the festival area. Beer and/or wine must be consumed within the confines of the festival area. The festival area will be completely surrounded by security fencing, with one entrance/exit, which will be staffed by volunteers at all times, and signage will be conspicuously displayed, prohibiting any alcoholic beverages from leaving the festival area. The applicant will provide personnel to verify the age of all participants who wish to purchase beer/wine. Each participant over the age of 21 will be provided with a visible marker (hand stamp) indicating their identification has been verified.

The applicant will have cash management policies in place that require cash drops and bank deposits at pre-determined times. Outside vendors will be responsible for their own cash management procedures.

Event participants may park in available public areas of Market Commons provided for regular and handicapped parking. Trailers and over-sized vehicles may not be parked in public parking spaces not providing for those types of vehicles.
